APPROVAL OF THE FY25 TAX LEVY

This Board Report contains information on the recommended 2025 Tax Levy.

The Committee of the Whole has reviewed the proposed 2025 Tax Levy. The proposed Tax Levy is not in excess of 105% of the 2024 Tax Extension. Therefore, no public hearing is necessary.

The amounts listed in this levy request are based on an estimated equalized assessed value of \$668,771,250 which represents a 4.42% increase over the 2024 equalized assessed valuation of commercial and residential property within School District #68 that is taxable.

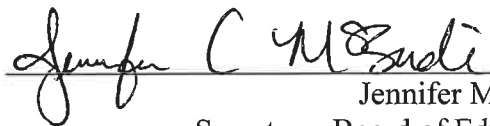

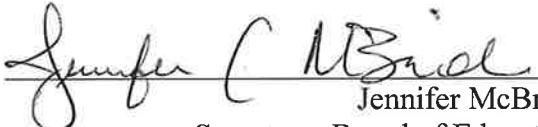

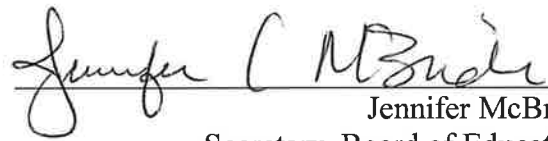
